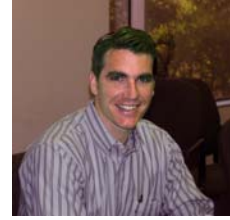

Responsible for supporting 500 employees spread across five facilities in the west Houston area for issues relating to mobile, desktop, and server platforms, hardware peripherals, software, and web technologies. Build & configure file & print and application servers, configure new user domain and email accounts, maintain & troubleshoot database server issues, and configure & maintain network print servers. Resolve LAN/WAN connectivity issues involving Cisco & Aureorean IPSEC VPN clients, CheckPoint SSL VPN clients, iPass remote connectivity software, Citrix Metaframe, terminal services, and dial-up networking. Created extensive technical documentation library. An important project completed while at National Oilwell included the migration of approximately 500 users from a Windows NT 4.0 domain to Windows 2003 Active Directory. The project covered designing the migration process and hiring & training 10 contractors to migrate the end users' network accounts, desktop profiles, and mailboxes using Active Directory tools. Another project involved the configuration & administration of GWI Software's c.Support web-based help desk application for 150 plus corporate engineering, SAP, and IT professionals spread across the globe. Besides setting up the software, I created technical documentation & trained the entire IT staff on how to utilize the application. Another project completed involved the configuration & deployment of the Cognos Finance financial application for desktop, web, and terminal services based client. Another project was the enterprise-wide roll out of multiple SAP front-end upgrades at 150 locations across the globe. A minor project completed involves the design and implementation of Microsoft's Windows Software Update Services (WSUS) patch management solution.
